

## Terms and Conditions - Refer a Friend

As a Premium Client, you can earn extra rewards when you refer a friend to Winstone Prime. When your friend deposits and trades, you can receive a bonus, subject to the following terms and conditions (“Offer Terms”):

In these Offer Terms:

- “Bonus” means the amount payable to you if you meet these Offer Terms;

- “Offer” means this Refer a Friend Offer, which is offered to you as a Premium Client under these Offer Terms;
- “We” “us” or “our” means Winstone Prime Markets Limited, Suite 305, Griffith Corporate Centre, P.O Box 1510, St Vincent and the Grenadines and
- “You” “your” or “yours” means you, if you meet the criteria of an Eligible Client under these Offer Terms.

### The Bonus
